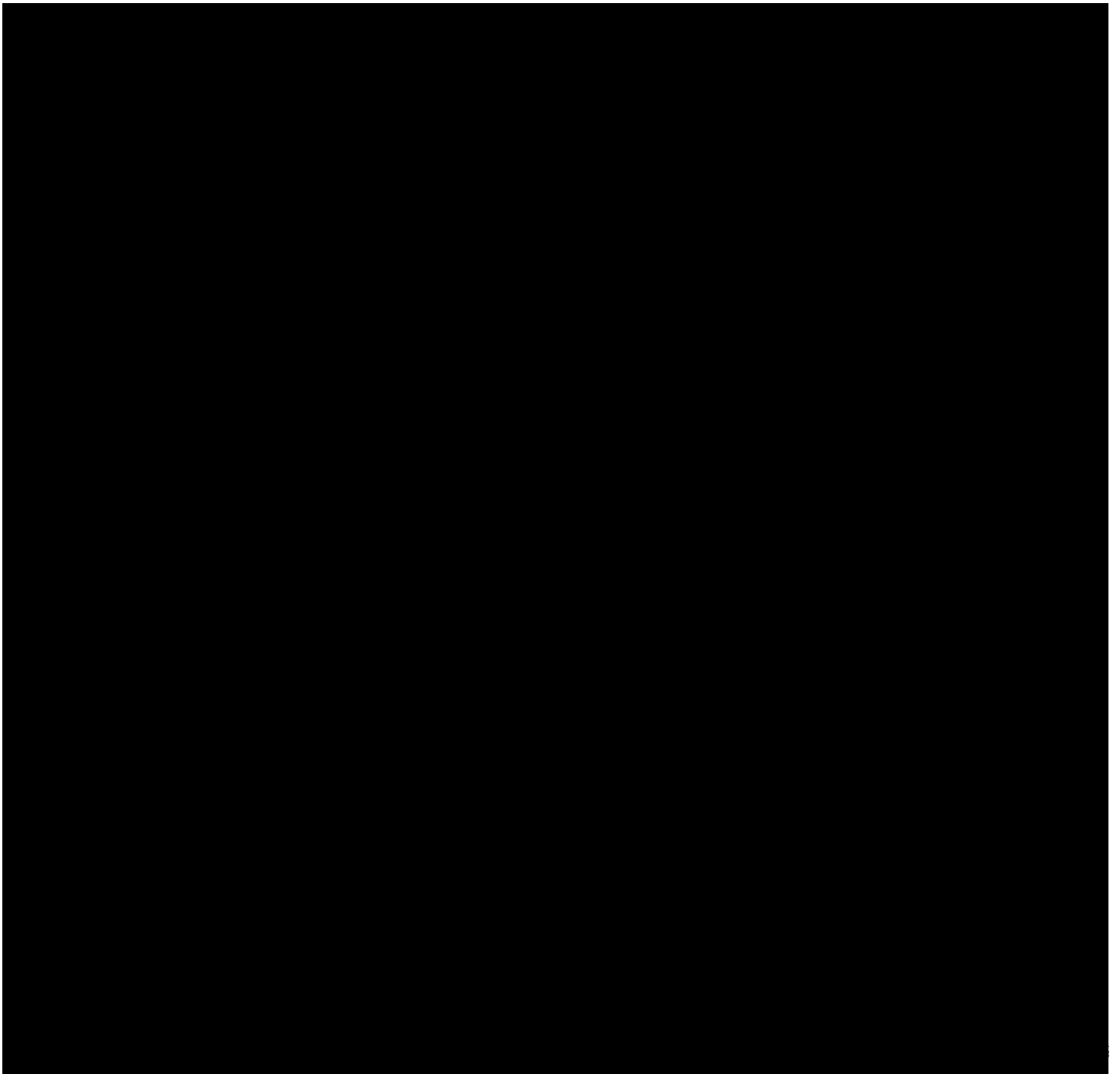

- Parents will have the opportunity to be a part of "Parent University" classes in spring 2018

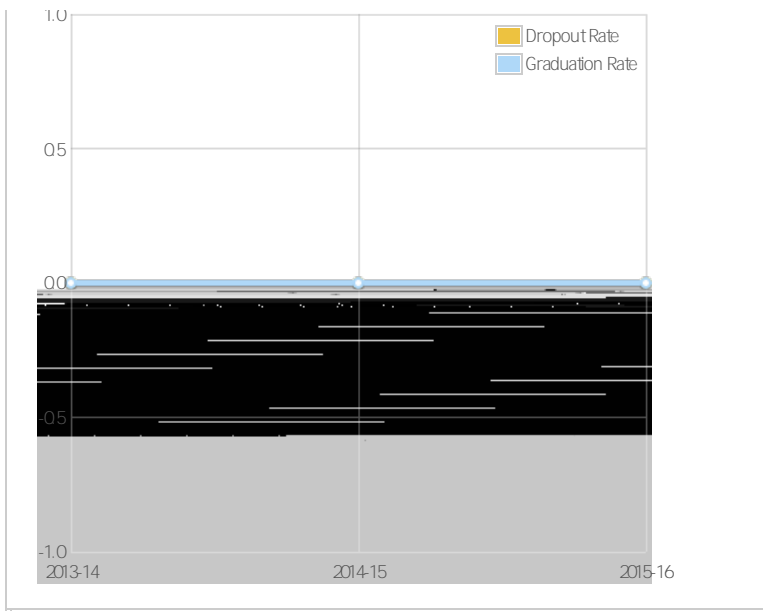
